<p><u>CONTROL MEASURES / PRECAUTIONARY ACTION TAKEN:</u></p>												
<p>1. Uneven Ground</p>	<ul style="list-style-type: none"> • Warn everyone of uneven ground and to be observant of where they are walking. • Advise walking around site (not running). • Teachers to check appropriate footwear. (Session information advises appropriate footwear.) • 1 x 2 = 2= Tolerable risk 											

2. Low branches	<ul style="list-style-type: none"> Warn everyone that there may be low branches so to be careful of their eyes. 1 x 2 = 2 = tolerable risk 			
3. Weather	<ul style="list-style-type: none"> Teacher to assess weather conditions and postpone session if dangerous weather conditions e.g. high winds Session information advises appropriate clothing. 2 x 1 = 2= Tolerable risk 			
4. Dogs	<ul style="list-style-type: none"> Advise everyone to stand still and fold arms if dogs come towards them. 2 x 1 = 2= Tolerable risk 			
5. Infections	<ul style="list-style-type: none"> Warn everyone not to touch any litter or dog faeces. Ensure everyone washes hands before eating/ drinking. Public toilets open from 8am. Session information advises covering cuts/ grazes. 2 x 1 = 2= Tolerable risk 			
6. Lost children and first aid	<ul style="list-style-type: none"> Teachers to ensure appropriate supervision and safety of children. Teachers to ensure adequate first aid provisions. In case of emergency, dial 999 yourself stating Beacon Park Bunker's Hill entrance WS13 6RA. Then, inform rangers on 01543 308867 who will open the appropriate barrier(s). 2 x 1 = 2= Tolerable risk 			
7. Water Hazards	<ul style="list-style-type: none"> Teachers to ensure appropriate supervision and safety of children. Warn everyone of open water. 2 x 1 = 2= Tolerable risk 			
8. Wildlife	<ul style="list-style-type: none"> Warn children not to touch/pick anything up unless they are sure it won't harm them. Warn children stinging nettles and brambles present. Teachers to ensure adequate first aid provisions. 1 x 2 = 2 = Tolerable risk
